is a 501(c)(3) nonprofit organization that provides individualized, all-inclusive support for people forced to travel long distances for abortion care.

We act as a dependable and consistent ally throughout our clients' journeys, taking care of all aspects of their itineraries, including local and long-distance travel, meals, lodging, childcare, and anything else that might make the experience more comfortable. Through direct support and in collaboration with a network of partners, we bridge the ever-widening gap between a pregnant person and their abortion provider. We get people to abortion care, whatever it takes.











Navigating an increasingly treacherous journey

When The Brigid Alliance launched in 2018, getting to and from an abortion provider was complicated and even impossible for many abortion seekers. Even before the Supreme Court's decision to overturn *Roe v. Wade*, nearly 90 percent of counties had no abortion provider. Today, five years since we founded our organization, the journey to an abortion provider has grown even more treacherous, with people of color and other disadvantaged groups disproportionately affected by state-level abortion bans.

Thankfully, The Brigid Alliance was built for this crisis. We exist to provide dependable support that enables people to travel long distances to get to abortion care. Perhaps most importantly, we are there for all of our clients who are navigating extraordinary barriers to accessing the healthcare they need.

The assault on abortion access hasn't ceased with the overturning of federal protections for abortion and resulting state-level restrictions. In fact, the *Dobbs* decision has opened the floodgates for egregious attacks on abortion all across this country. Courts have challenged access to Mifepristone, a safe and effective abortion medication that has been on the market for years.

Message from the Incoming Board Chair

Idaho passed a law forbidding helping a person under the age of 18 obtain abortion pills or leave the state for abortion care without parental permission. And in Texas, two cities and two counties have enacted local ordinances that criminalize transporting individuals through their jurisdiction for the purpose of obtaining an abortion out of state. Abortion seekers and advocates face a long road ahead. But one thing is for certain: our unwavering commitment to ensuring abortion is accessible to people of all backgrounds and all walks of life.

True to our founding principles, we continue to focus on helping people disproportionately impacted by abortion restrictions get to abortion care, including people living at or below the federal poverty line, people of color, minors, undocumented immigrants and refugees, people with disabilities, and survivors of abuse. The path forward may be arduous, but we are not going anywhere. Thanks to support from our donors and partners, The Brigid Alliance is here to stay and will not rest until abortion is borderless, burden-free, and accessible to all.

Message from the Interim Executive Director

Overcoming roadblocks

We are experiencing a historic crisis for abortion access in the United States.

Thousands of people are being forced to carry unwanted or unsafe pregnancies against their will, unless they can figure out a way to get to an abortion provider. This often means traveling halfway across the country to an unfamiliar city and navigating countless hurdles along the way. But that's where The Brigid Alliance comes in. Wherever one of our clients needs to go, we find a way to get them there—and get them back home—safely and with dignity.

As this crisis worsens, the number of people who need our services is surging. We, in turn, are growing our team, and strengthening our capabilities, and expanding our network so we can help more and more people. We have increased our client services capacity by nearly 50%, hiring 7 new staff members across the organization to provide holistic support for an ever-growing number of clients.

We vastly grew our network of providers while streamlining our referral system, allowing our coordinators to serve more clients. And we have made an unprecedented set of grants to local and regional organizations across the country to continue growing the whole network's capacity for providing practical support to abortion seekers.



Message from the Interim Executive Director

I am in awe of the tenacity of The Brigid Alliance client service coordinators, who do everything in their power to ensure people can access the abortion care they need. In collaboration with our partners, they charter private flights with volunteer pilots for people who live hours from a regional airport. They arrange cash drops for people who are unbanked. They purchase winter clothing for people who have never traveled to a cold climate. And they reschedule flights when there is a hurricane or blizzard, and much more.

They are a beacon to thousands of people who would otherwise have no way to get the abortion care they need. We know our work is changing people's lives for the better, and it's having positive ripple effects across families and entire communities. In an otherwise dark time for abortion seekers all across this country, their persistence inspires me and it gives me hope.

Getting clients there and back

Today more than ever, getting to an abortion provider in the United States means facing a dizzying array of logistical and financial challenges. This is where The Brigid Alliance steps in. Our coordinators create completely customized itineraries that account for everything our clients need to get to an abortion provider and back home again. Importantly, we bring compassion, respect, and reassurance to every single interaction we have with our clients.



TRANSPORTATION

We arrange and pay for local and long distance transportation.



LODGING

We book and pay for hotel stays.



MEAL ASSISTANCE

We provide stipends for food costs.



PERSONAL TRAVEL ITEMS

We pay for car repairs, temporary cell phones, cold weather clothing, car seats, and more to account for everything a client needs to get their procedure.



PHYSICAL COMFORT STIPEND

We pay for sanitary pads, pain medication, and other items so that people are as comfortable as possible during and following their procedure.



CHILDCARE

We provide stipends for child care.



VIRTUAL ACCOMPANIMENT

Our client-facing coordinators are full-time staff, trained to provide non-judgmental, trauma-informed and compassionate support at every step of the journey, and until they return home safely.



POST-SERVICE REFERRALS

We provide referrals for follow-up OBGYN care, housing assistance, and emotional support after our clients' procedures.



The rising costs of accessing abortion care

Since the Dobbs ruling in June 2022, the cost of accessing abortion care has increased significantly, with an average cost of our clients' itineraries now exceeding \$2,300. There are a few reasons for this increase:



HAVING TO TRAVEL LONGER DISTANCES FOR ABORTION CARE:

Since large swaths of the country have outlawed, criminalized, or severely restricted abortion care, travel time and distance has skyrocketed. Our clients now travel an average of 1,300 miles round trip to access an abortion provider, a 30% increase since before the *Dobbs* ruling.





INCREASED COSTS OF SERVICES:

The Brigid Alliance is not immune to the rising costs of travel – when the price of airline tickets increases for consumers, that price increases for our clients. We also increased our meal stipend from \$40 per day to \$75 per day to account for increased food costs nationwide.



ACCOUNTING FOR THE CONTRIBUTIONS OF OUR CLIENT SERVICES TEAM:

Over the past year, we made important investments in technology, security, compensation and benefits, to support the sustainability and growth of our organization. To more accurately capture the cost of helping a client access abortion care, we have begun factoring 20 percent into the reported cost of each itinerary, which includes the organizational and infrastructure cost necessary to do this work.



NEW SERVICES FOR CLIENTS:

In April 2023, we began providing new services based on the feedback we received from clients. For example, we now offer a comfort stipend and support additional aftercare expenses, to ensure our clients receive all the care they need before, during, and after their procedure.




The profound inequities in abortion access have grown even deeper in the last year. Since October 2022, we have seen four more states enact total or partial abortion bans and multiple courts rule to restrict access to medication abortion.

But there are also many reasons to be hopeful, with Americans affirming the right to abortion access every time it's been put up for a vote, and our legion of donors stepping up to help ensure people can get the care they need.

We raised our voice during the one-year anniversary of the Dobbs decision to call attention to the hurdles abortion seekers face in accessing care, and The Brigid Alliance's work to support them.



We spoke out about the harmful effects of state abortion bans and what we are doing to support people affected by them.



The Daily Show shined a spotlight on our work on national television and encouraged supporters to donate to us.



Our supporters fundraised for our work in inspiring and creative ways.



High-profile musical artists **continued to raise funds** for our work, including the New Pornographers.



Natasha Pickowicz celebrated the launch of her book *More than Cake* with a benefit **bakesale for The Brigid Alliance**. More than 40 bakers participated in the bake sale, and there was a line of excited sweet tooths wrapped around the building all day.



40 authors came together to write an anthology, *Hell Hath No Fury*, and **donated 100% of the proceeds** to organizations fighting for reproductive rights, including The Brigid Alliance.



Our friends at **Tickled Hot Pink hosted a virtual raffle and auction** that raised more than \$30,000 for The Brigid Alliance. The lively auction featured popular festival tickets, getaways, wellness experiences, sports tickets, and so much more.



The New York Chapter of the American Academy of Matrimonial Lawyers **named The Brigid Alliance their honoree** for their annual gala, an event that featured Alvin Ailey dancers, dinner, live music, and remarks from Sarah Moeller, our Senior Director of External Relations.



We advocated for abortion seekers and championed policies that affirmed the right to abortion.

We spoke out against efforts to restrict access to medication abortion in the courts.



At a critical time when abortion clinics across the country are being forced to shut down, we used our social media platform to advocate for our partner the DuPont Abortion Clinic, which was blocked by anti-abortion extremists from opening a new clinic in California.

I feel very strongly about making sure abortion services and support are accessible across the country for all genders."



Bolstering practical support for clients

The Brigid Alliance relies on a network of regional and state-level grassroots abortion funds and practical support organizations to help ensure people can access abortion services.

These groups are working urgently to meet increased demand for their services but face funding shortfalls. In 2023, we made the unprecedented decision to grant \$1 million to more than 20 groups. While The Brigid Alliance is not a funder, it is our mission to provide and expand practical support for people who need to travel to access abortion care.






In FY 2023, 76% of expenses supported program work getting clients to their abortions and back home safely.
